

The Coryell County Commissioners Court convened at 9:00 a.m. with all members in attendance to hold a Public Hearing and a Public Meeting with County Judge John Firth presiding over the meeting.

1. County Judge John Firth called the Public Meeting on the Proposed Budget meeting to order.
2. County Tax Assessor Justin Carothers and Gatesville Messenger Reporter Larry Kennedy attended the hearing.
3. Judge Firth Closed the Public Hearing at 10:15 a.m. and entered into the Public Meeting at 10:16.
 1. County Judge John Firth called the meeting to order.
 2. The court voted unanimously to approve the Fiscal Year 2010 budget for Coryell County after a motion by Commissioner Elizabeth Taylor and a second by Commissioner Daren Moore.
 3. Commissioner Elizabeth Taylor moved to decrease the property taxes by the adoption of a tax rate of \$.3975. The motion was seconded by Commissioner Daren Moore and the court vote unanimously to set the tax rate at \$.3975 per \$100.00.
\$.37465 per \$100 for the purpose of maintenance and operation
\$.02285 per \$100 for the purpose of principal and interest on debts.

4. The court voted to adjourned this meeting after a motion by Commissioner Jack Wall and a second by Commissioner Don Jones.
