CORYELL COUNTY RESOLUTION No. 2021-12

ADOPTION OF COUNTY REDISTRICING PLAN
FOR COMMISSIONER PRECINCT LINES

WHEREAS, the data from the 2020 Census reflects an imbalance of population within the Commissioner Precincts greater than 10% deviation; and,

WHEREAS, precinct lines must satisfy the equal protections guaranteed to citizens by the 5th, 14th, and 15th Amendments to the United States Constitution; and,

WHEREAS, a redistricting plan must be in compliance with the Voting Rights Act of 1965, as amended in 1975 and 1982;

THEREFORE, BE IT RESOLVED, that as the Commissioners Court, we do hereby ADOPT the plan to redistrict and redefine the Commissioners Precincts as shown by the documentation contained in EXHIBIT A & B, attached hereto.

This redistricting will become formally effective January 1, 2022 and will be used as the basis for conducting future elections thereafter.

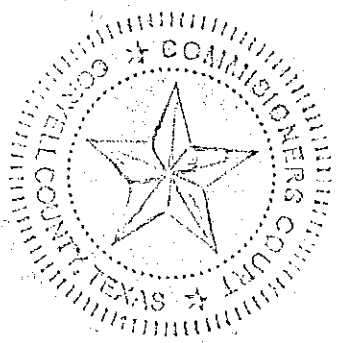
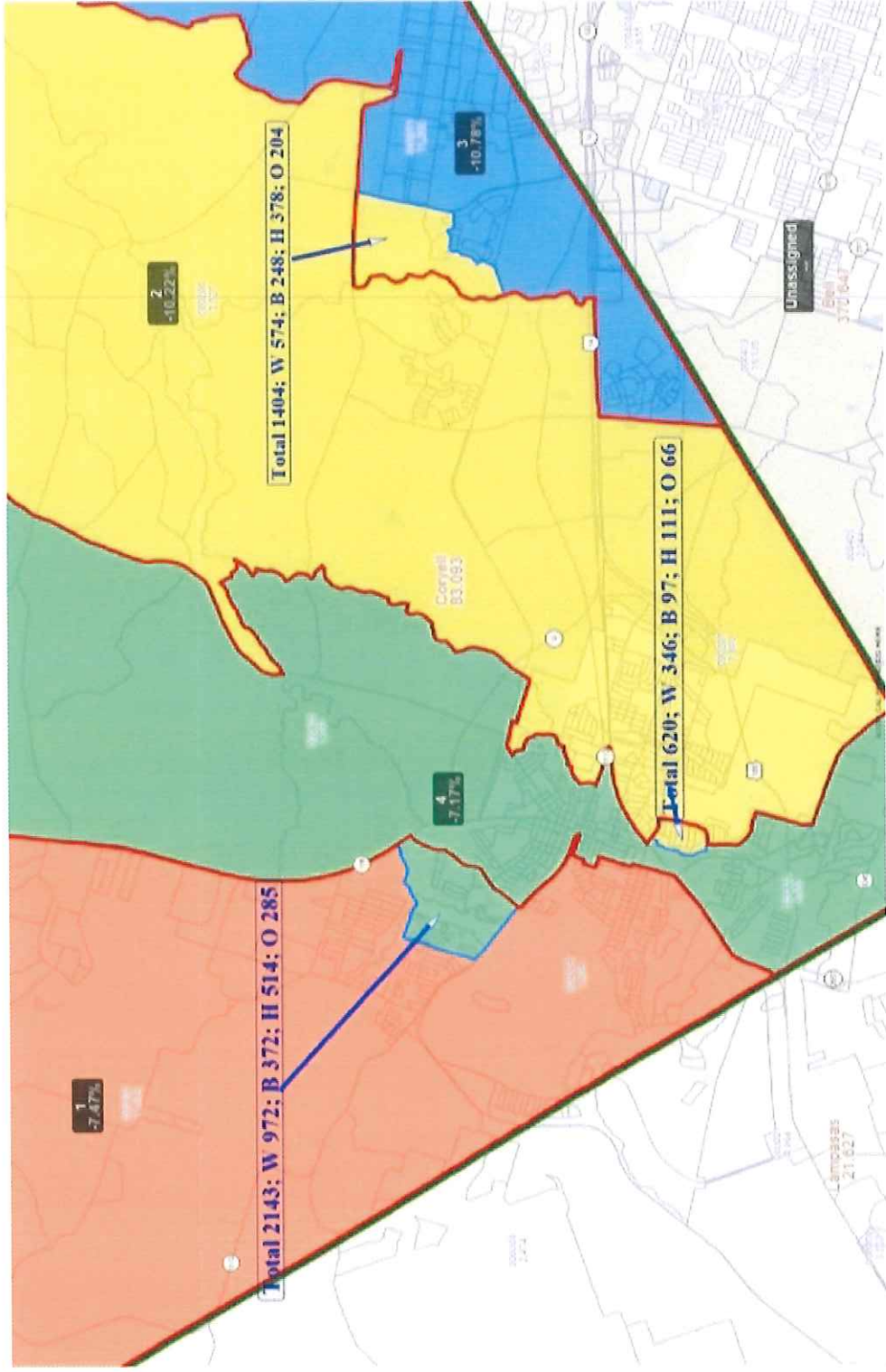
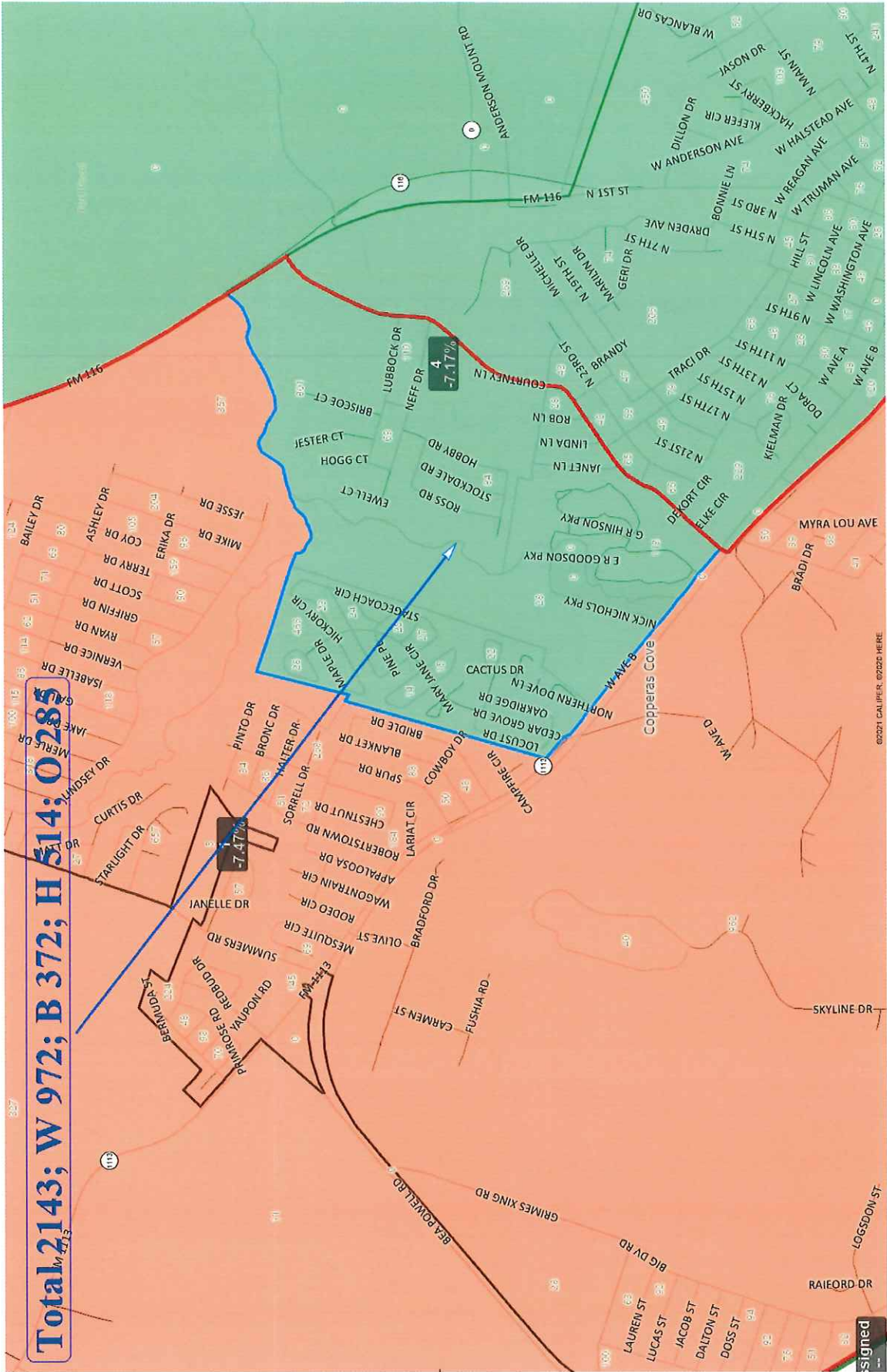
