ORDER RESCINDING COURT ORDER 2022-27 – LOCAL BURN BAN

WHEREAS the Commissioners' Court of Coryell County passed and approved Order 2022-27 on 25 October 2022, which prohibited the outdoor burning of brush, trash and debris in the unincorporated areas of Coryell County; and,

WHEREAS, the County Judge is authorized to make a determination and now finds that environmental circumstances have changed to such a degree that the responsible burning of brush and debris outdoors does not currently create a public safety hazard; therefore,

IT IS HEREBY ORDERED by the County Judge of Coryell County that Court Order 2022-27 be rescinded effective 12:00 noon on 8 November 2022.

- 11. The Court suspended the current order for the burn ban after a motion by Commissioner Kyle Matthews and a second by Commissioner Ryan Basham.

- 13. Roger Miller, County Judge, gave an update on the Habitat Conservation Plan.
- 14. Brandon Belt, County Attorney, gave an update on the amended plats with the City of Gatesville.

- 16. The Court authorized Southwest Architects to move to Phase II on the Leon St. Annex after a motion by Commissioner Scott Weddle and a second by Commissioner Kyle Matthews.
- 17. Discussion was held regarding final designs and construction plans for jail expansion.
- 18. The Court authorized Southwest Architects to move into Phase II on the jail expansion after a motion by Commissioner Kyle Matthews and a second by Commissioner Ryan Basham.
- 19. Vince Viaille with Specialized Public Finance, Inc gave a presentation on the financing of the jail expansion and Leon St. Annex.
- 20. The Court authorized SPFI to move forward with Tax Note preparation subject to the amount to be determined by the Court at a later date after a motion by Commissioner Scott Weddle and a second by Commissioner Kyle Matthews.

- 22. The Court authorized the Sheriff to enter into an agreement with Enterprise Fleet Management Services for maintenance and fleet management for the FY2023 and to be expensed out of the Sheriff's Office maintenance budget; this will eliminate the ambulance ending in 70134 and the Humvee by description only after a motion by Commissioner Scott Weddle and a second by Commissioner Ryan Basham.
- 23. The Court approved the Addendum to LESO Program after a motion by Commissioner Kyle Matthews and a second by Commissioner Scott Weddle.
- 24. The Court approved an increase in rates with Comal County to \$100.00 per day per inmate after a motion by Commissioner Ryan Basham and a second by Commissioner Kyle Matthews.
- 25. The Court accepted a donation from Michael Robinson for canine Winston in the DA's office after a motion by Commissioner Ryan Basham and a second by Commissioner Kyle Matthews.
- 26. The Court will move forward with grant administrative services for SS4A-Safer Streets for All with CTCOG after a motion by Commissioner Scott Weddle and a second by Commissioner Kyle Matthews.
- 27. The Court voted to pay bills in the amount of \$947,076.89 after a motion by Commissioner Kyle Matthews and a second by Commissioner Ryan Basham.
