NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, That certain Deed of Trust (the "Deed of Trust"), dated March 21, 2022, from Abel Rincon and Maria A Rincon ("Borrower"), as Grantor to Carmen Mejia, Trustee, filed for record in Real Property Records of Coryell County, Texas, more particularly described therein, which serves as security for a \$76,000.00 promissory note described therein (the "Note") executed by Borrower, payable to the order of Centex Casas, LLC.

WHEREAS, the undersigned has been appointed Substitute Trustee in the place of the said original Trustee, upon the contingency and in the manner authorized by the Deed of Trust; and
