Request for Qualifications for Engineering/Architectural Services

Coryell County is seeking to enter into an **engineering services** contract with a State of Texas-registered engineer to assist with pre-award and post-award engineering services of its proposed FEMA Public Assistance (PA) Grant project(s) if funded by FEMA.

The following outlines this Request for Qualifications.

- I. **Scope of Work:** The engineering contract will encompass all project-related engineering services to the County, including but not limited to the following:

Pre-Award:

- Application Development including Scope of Work and schedule
- Preliminary cost estimates
- Provide assistance regarding feasibility and effectiveness
- Benefit Cost Analysis (BCA)
- Tables and supporting documentation for applications
- Respond to FEMA/State requests for information (RFI)

Post-Award:

- Preliminary and final design plans and specifications
- Preparation of the bid packet
- Bid and Award Support
- Contract Management and Construction Oversight including all field testing and inspections (interim and final)
- Construction closeout
- Other special services

- II. **Statement of Qualifications:** Coryell County is seeking to contract with a competent engineering firm, registered to practice in the State of Texas. Please provide the following information:

- Brief history of the proposing entity, including general background, knowledge of and experience working with the relevant agency
- Related experience in applying for federally funded construction projects
- A description of work performance and experience with FEMA grant projects including a list of at least 3 references from past local government clients
- A statement substantiating the service provider's resource and the ability to carry out the scope of work requested in a timely manner
- Describe the service providers capacity to perform as well as resumes of all employees who will or may be assigned to provide services if your firm is awarded a contract through this solicitation

III. Proposed Cost of Services: Coryell County reserves the right to negotiate with any and all engineers/engineering firms that submit statement of qualifications, per the Texas Professional Services Procurement Act and the Uniform Grant and Contract Management Standards.

IV. Evaluation Criteria: Proposals received will be evaluated and ranked according to the following criteria:

Coryell County will score and rank all eligible respondents. The County will negotiate a contract with the highest scoring respondent. If a contract cannot be reached, then the County will move down the list until a contract can be agreed upon. The County will issue a task order for the identified Scope of work.

V. Submission Requirements

- A copy of your current **certificate of insurance** for professional liability.
- **A statement of conflicts** (if any) the proposing entity or key employees may have regarding these services. The statement should include conflicts, as well as any working relationships that may be perceived by disinterested parties as a conflict.
